POSTING FOR COMMENT

The Housing Authority of Kansas City, MO has completed a review of its Public Housing flat rents as required by regulations. It is required that flat rents established are no lower than 80% of the current HUD-published Small Area Fair Market Rents (SAFMR). The proposed effective date for the flat rents is February 1, 2026. See Exhibit A & B.

The Housing Authority will visit each Development for explanation and comments beginning November 18, 2025. The Housing Authority will also accept written comments through February 1, 2026. Written comments must be received before 5:00 p.m. on February 1, 2026, and must be submitted to:
